If split, use sponge to wipe up the ink. Place it in closed container for proper disposal. During working for clean up, put on rubber gloves and goggle to avoid contacting ink to skin and eyes.

**Handling Precautions** : In use of ink, avoid contact with skin and eyes. Do not dismantle the cartridge.

**Storage Precautions** : Store in dry place away from strong oxidizers. Do not store ink or the cartridge in high or freezing temperature. Avoid direct sunlight.

Respirators are not needed for normal use. But if there is potential for significant dermal contact, wear appropriate impervious clothing and gloves, also wear safety glassed.
